For Institute Level Seats

Institute Level Round - I for admission to First Year of Four Year Degree courses in Engineering / Technology for the academic year 2016-17 against 20% Institute Level seats in Electronics Engineering, Computer Engineering, Information Technology and Electronics and Telecommunication Engineering is scheduled **on 08/07/2016 at 2.00 p.m.** The round will be conducted as per merit list by way of Counselling.

Instruction for Institute Level Round- I

1] If a candidate remains absent at the scheduled time and date, he/ she loses the right of admission. The candidate next in the Merit List will then be considered for the admission.

* The difference in the final fee & interim fee will have to be paid by students after final fee is sanctioned by the Fees Regulating Authority.

* In addition to the above fees, candidates who have passed XIIth from other than Maharashtra State Board are required to pay Rs. 320/- in cash towards University of Mumbai – Provisional Eligibility Fees.

3] Payment will be accepted in Demand Draft drawn in favour of “Principal, Sardar Patel Institute of Technology”. No Cash will be accepted.

4] If the admission is granted on inter se merit then the candidates should submit following original documents:

- 4] Leaving Certificate
- 5] Migration Certificate [wherever applicable]
- 6] Domicile Certificate of Candidate / Father or Mother of the Candidate is domiciled in the State of Maharashtra.
- 7] Certificate in pro-forma A/B-1 or B-2/G-1 or G-2 as per Govt. of Maharashtra, State Common Entrance Test Cell brochure. [If applicable]
- 8] Aadhar Card Xerox
- 9] Gap Certificate [If applicable]
- 10] Print out of duly signed University of Mumbai Pre-Admission online Registration Form (website : mum.net.in) (to be submitted after admission)
- 11] Duly signed print out of Anti-Ragging Affidavit submitted online on www.antiragging.in by candidate and parent. (to be submitted after admission)

- They are also required to submit three sets of attested photocopies of the above documents and two passport size photograph with the admission form. In case the original certificates are submitted to other colleges, they should produce the original and attested photocopy of admission letter issued by that college stating the list of documents submitted to that college during admission & retention letter of admitted college for verification.
- All students are required to **Scan their documents before submitting** to the college for admission. These scanned documents have to be forwarded by the student to the college at a later date.

6] Candidates should take note that admission will be given only if the candidate remains present in person and produce Demand Draft for the fees and Original documents at the time of admission.
