3] Payment will be accepted in Demand Draft drawn in favour of “Principal, Sardar Patel Institute of Technology”. No Cash will be accepted.

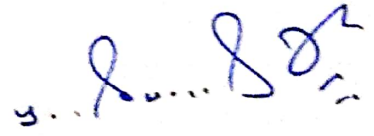
4] If the admission is granted on inter se merit then the candidates should submit following original documents:

- 5] Leaving Certificate
- 6] Migration Certificate [wherever applicable]
- 7] Domicile Certificate of Candidate / Father or Mother of the Candidate is domiciled in the State of Maharashtra.
- 8] Certificate in pro-forma A/B-1 or B-2/G-1 or G-2 as per Govt. of Maharashtra, State Common Entrance Test Cell brochure. [ If applicable]
- 9] Aadhar Card Xerox
- 10] Gap Certificate [ If applicable]
- 11] Print out of duly signed University of Mumbai Pre-Admission online Registration Form (website : [mum.net.in](http://mum.net.in) ) ( to be submitted after admission)
- 12] Duly signed print out of Anti-Ragging Affidavit submitted online on [www.antiragging.in](http://www.antiragging.in) by candidate and parent. (to be submitted after admission)

- They are also required to submit three sets of attested photocopies of the above documents and two passport size photograph with the admission form. In case the original certificates are submitted to other colleges, they should produce the original and attested photocopy of admission letter issued by that college stating the list of documents submitted to that college during admission & retention letter of admitted college for verification.
