Instructions for candidates to be followed at the time of reporting on 13-08-2019.

- 1] If a candidate remains absent at the scheduled time and date, he/she loses the right of admission. The candidate next in the Merit List will then be considered for the admission.
- 2] Fees payable by candidates for 2019-20 is Rs. 160804/- Payment will be accepted in Demand Draft drawn in favour of "Principal, Sardar Patel Institute of Technology". **No Cash will be accepted.**
- 3] * Those candidates who have already been admitted to S.P.I.T. through Institute Level seat and aspire for change in branch will have to produce DD of Rs. 1,000/- as cancellation charges.
* Those candidates who have already been admitted to SPIT vide CAP before and aspire for change in branch vide Institute Level seats will have to produce DD of difference amount (difference between actual fees paid and Rs. 160804/-) in addition to Rs. 1000/- as cancellation charges. Such candidate are required to present the original fee receipt of fees paid at the time of admission and retention letter.
- 4] Candidates should take note that admission will be given only if they produce Demand Draft for the fees and Original documents or Retention letter of other college at the time of admission.
- 5] If the admission is granted on inter se merit then the candidates should submit following original documents 1] CET Score Card 2] S.S.C. Marksheets 3] H.S.C. Marksheets 4] Leaving Certificate 5] Domicile Certificate. In case the original certificates are submitted to other colleges, they should produce the original and attested photocopy of fee receipt and document retention letter from the admitted college for verification.

For Reserved Category Candidates: (For vacancy after CAP round III if any)


1. The Round for reserved category candidates will be conducted on 13.08.2019 at 12.00 noon in the Conference Room of Sardar Patel Institute of Technology (room no. 008).
2. Candidates of Reserved Category in which vacancy is shown are requested to report to room no. 008 at 12.00 noon sharp along with their Caste Certificate, Caste Validity Certificate, Non-Creamy Layer (wherever applicable) issued & valid in the State of Maharashtra in addition to all documents listed in point no. 5 & D.D. of Rs. 160804/- towards fees.
3. Vacant seats after CAP will be filled in by the candidates from the same category for which it was earmarked during CAP. Any category vacancy remaining after this will be filled by general merit list. Kindly note that full fees (as open category fees) will be payable by all the candidates including category candidates till course completion. **Unless all document listed above and fees of Rs.160804/- are submitted, the admission against particular category tag will not be given.**
