- vi. Statement of Marks for Bachelors Degree Examination (All Sem Marksheets, Pass as well as Fail Marksheets)
- vii. Bachelors Degree Passing Certificate
- viii. Bachelors Degree Transfer Certificate
- ix. Gate Score Card / Experience letter
- x. School / College Leaving Certificate after qualifying examination
- xi. Passport size 2 photographs
- xii. Domicile Certificate of Candidate / Father /Mother for Type A/ B
- xiii. Certificate in Pro-forma A for Type C Candidate
- xiv. Certificate in Pro-forma A for Type D Candidate
- xv. Certificate in Pro-forma G1 or G2 for Type E Candidate
- xvi. Caste Certificate (if applicable)
- xvii. Caste Validity Certificate (if applicable)
- xviii. Non-Creamy Layer Certificate (if applicable)
- xix. Sponsorship certificate in Proforma W 1 /W2 (applicable to sponsored candidate)
- xx. Gap certificate (if applicable)
- xxi. Photocopy of Aadhar card
- xxii. Photocopy of first page bank passbook (applicable to Gate qualified candidates for AICTE scholarship application)
- xxiii. Migration Certificate (if qualifying Examination is not from Maharashtra)
