Dear Students & Parents,

We thank you for applying to our institute seeking admission.

Our Round 1(A) for After CAP Vacancies **against Category Seats** will be conducted **OFFLINE** on 11th September 2025, starting from 9 a.m. In this round, the seat earmarked for a particular category will be offered to the candidates of the respective category only.

Our Round 1(B) for vacancies **against All India (AI) seats** will be conducted **OFFLINE** on 11th September 2025 from 2 p.m. onwards.

Our Round I (C) for After CAP Vacancies against **Open category** and **Institute Level seats** will be conducted **OFFLINE** on 12th September 2025 from 9 a.m. Please note that in this round all vacancies at the end of round 1(A) and 1(B) on 11th will be clubbed together with vacancies against Open Category, and admissions on all seats will be given strictly on **inter-se-merit** only as per institute merit list based on MH-CET percentile score only.

Please read the instructions carefully for the admission rounds.

FEES:

Fees instructions for both the After CAP and Institute Level rounds are explained below:

Candidates must pay the full fees as specified in the matrix below via :

Demand Draft drawn in favor of "Principal, Sardar Patel Institute of Technology" payable at Mumbai. Please note that you will be submitting this DD to the institute during the round itself

OR

Online transaction via Netbanking on the spot during the round itself. You are also requested to enable your NetBanking service and adjust your payment limit to accommodate the full fees well in advance. Only NetBanking will be accepted. No other mode of online payment (such as UPI/IMPS/NEFT/RTGS) will be accepted. You should finish the online transaction within five minutes. Payment through NetBanking should reflect in the institute account within five minutes of offering the seat. In case there are any issues with the NetBanking transaction observed after the allotment of the seat, the institute reserves the right to revoke the seat offered to you in favor of the next eligible candidate as per merit. The panel will not wait longer than five minutes for your successful payment before moving on to the next candidate. Only **major** scheduled and private banks are available for NetBanking.

However, we advise you to pay via DD to avoid any online banking inconveniences.

For candidates who have not secured admission to our institute via CAP:

Our institute fees are:

- After CAP seat fees: Rs. 2,12,125/-
- Institute Level seat fees: Rs. 3,17,125/-

For candidates who have **applied** for both After CAP and IL seats, and are interested in **both** After CAP and IL seats, they must prepare **TWO** DDs as follows:

1. One DD of Rs. 2,12,125/-
2. One additional DD of the balance amount of Rs. 1,05,000/-

This will enable you to either take admission against CAP vacancies or against IL seats.

For SC candidates securing an SC After CAP seat, the fees is: Rs. 2,125/-.*

* The facility of SC category seat fee is subject to the sanction of scholarship/freeship from the Social Justice and Special Assistance Department of the Government of India. If not sanctioned, then you will be required to pay the full fees as per the open category after CAP seat type (Rs. 2,12,125/-) for every year of the four-year course. You need to give an undertaking in that regard at the time of admission.

For candidates who have already secured a seat in our institute via CAP:

For candidates who are interested only in After CAP seats, prepare a DD as per the “DD1” column in the matrix below, to be submitted after securing a seat in the After CAP round.

For candidates who are interested in both After CAP and IL, bring DDs as per the matrix shown in **DD1 and DD2** below for the admission counseling rounds.

Note that, in addition to the fees mentioned above, you must also pay the cancellation fees of Rs. 1,000/- as per the CET Cell mandate towards cancelling the earlier allotted seat. You may pay these cancellation fees via UPI or cash.

Please note that all those candidates (category/open/AI) who will secure admission at the institute level and who have not filled institute institute-floated application form, but have applied for ACAP/IL seats through the CET portal, must pay an application processing fee of Rs. 2,500/- on the spot.

REPORTING OF CATEGORY ROUND (1A) on 11th September 2025

The category round will start at 9.00 A.M. All category students should report to the institute as per the table below:

The Admission Round against After CAP Vacancies for category candidates will be held on 11th September 2025 from 9 AM onwards, offline. You are required to assemble in the institute premises by 8:30 AM along with all original documents/retention letter for document verification.

If you fail to bring the original documents/retention letter or to bring the DDs (as described in the Fees section above) at the time of the admission round and fail to pay the full fees, you will not be able to secure a seat.

Documents needed for admission for reserved category students

1. Caste Certificate
2. Caste Validity
3. Non-Creamy Layer Certificate (wherever applicable)

Candidates who do not secure a seat in this round are eligible for further Open Category After CAP and Institute Level seat rounds in the OPEN merit list, and can participate in further rounds. However, such candidates will have to pay the full fees for every year of the four-year course.

ROUND FOR AI SEATS (1B)

Reporting timing for all eligible candidates as per the All India merit list on 11th September 2025 is at 2.00 pm.

Candidates who have applied to S.P.I.T. for ACAP seats through S.P.I.T. / CET CELL portal should report to the institute as per their JEE percentile as per table below:

If you fail to bring the original documents/retention letter or to bring the DDs (as described in the Fees section above) at the time of the admission round and fail to pay the full fees, you will not be able to secure a seat.

Candidates who do not secure a seat in this round will be eligible for ACAP and IL open rounds if they appeared for the Maharashtra state CET.

2. The candidate must provide original Documents/Retention letter for verification. **The candidate must also bring one complete set of photocopies of all documents to the counseling round.**
3. The candidate must pay full admission fees as described in the Fees section above.

If, for any reason, you are unable to attend the admission round at your specified slot or are unable to make the payment, you will be considered for admission as and when you can attend the round/make the payment of fees (**subject to the vacancies available at that point of time**).

Your admission confirmation is subject to the submission of original documents and the successful payment of fees.

Please note that the admission schedule for Round 2 as well as subsequent rounds, is subject to change if unforeseen circumstances occur.
